INFORMATION FOR BIDDERS ON COUNTY TRUSTEE PROPERTIES

JUNE 15, 2011

The Stone County Commission has decided that the best way to handle the County Trustee properties is to offer them for public sale immediately following the Collector's annual land tax sale held on the fourth Monday in August of each year.

Before the annual land tax sale, the Collector will have available a list of the properties held by the Trustee. The properties will also be listed on the Collector's website. The Trustee will be available after the sale to have discussions with prospective purchasers.

The Trustee will take sealed bids, due on Tuesday, September 29, 2011. The Trustee may reject any bid, or negotiate between or among bidders to secure the highest price.

For all bids accepted, the Trustee will add \$175 to cover the County's title search expense, and the Collector will calculate an amount to cover the Collector's advertising and notice expenses.

After being notified of a successful bid, each successful bidder must deposit with the Trustee the amount of the bid, \$175 to cover the County's title search expense, and the amount calculated by the Collector to cover the Collector's advertising and notice expenses. The Trustee will then order a limited title search solely to determine whether there are any recorded mortgages, liens, et cetera. It will take about 30 days for the title search report to be provided to the Trustee.

The statutes provide a 90-day period after notice in which to redeem the property. If the report shows a recorded mortgage, lien, et cetera, the Trustee must give 90 days' notice to redeem. If the property is redeemed, the purchaser's money will be refunded.

If the report shows no recorded mortgage, lien, et cetera, or if the property is not redeemed within 90 days after the notice is given, the Trustee will provide an affidavit to the Collector and obtain a Collector's deed. Upon receipt of the Collector's deed, the Trustee will convey the property to the successful bidder.

The purpose of the County's title search is to satisfy the statute and determine if recorded liens exist. It is not to determine whether the Trustee and the County have good and marketable title. The Trustee will inherit whatever title the "named taxpayer" had.

A successful purchaser should plan on the expense of another title search, and the expense of having an attorney file a lawsuit to quiet title to the property purchased.
